III. Continuation of Business from Previous Meeting

1. Status of the \$135,000 in Affordability grants awarded— Kerrick

- a. Ashland Family YMCA - \$50,000
- b. Avery Street Preschool - \$30,000
- c. Mountain Star Preschool - \$20,000
- d. Ella's Classroom AKA ABC Montessori - \$35,000

Gooden provided an update to the committee that the four Affordable Childcare Grant Program award checks have been issued

2. "Mind the Gap": Strategies for filling gap in childcare slots due to closing of Children's World Montessori – Paula and John

- Love spoke with leaders of the Presbyterian Church who would like to find renters for the space previously occupied by Children's World. The committee discussed the need for preschool slots in the community and will connect interested parties.
- The committee discussed the Unitarian Church is exploring its options for renting out its space to a childcare program.
- The committee discussed reaching out to any local entities that have received a grant from the state's Child Care Infrastructure Fund to better understand their plans and goals.
- Love reached out to Rogue Community College for data on childcare provider graduation rates and placement strategies to learn more about the potential supply of qualified staff. He is waiting for information.
- The committee discussed reaching out to Tom Cole with Kids Unlimited - Love will reach out and update the committee.
- The Southern Oregon University board is expected to decide later this month regarding the planned Senior Center that may co-locate early learning opportunities.

3. Update chart about progress on the committee's goals (see agenda packet)

- The committee reviewed and discussed these goals — members will send Love updates / notes
- Goal #1 - Ashland Family YMCA received 7 preschool promise slots at Talent site which are available to Ashland Families
- Goal #3 - Ongoing with Mind the Gap conversation and efforts to connect providers with partners and resources
- Recent zoning changes now allow for more siting options
- The committee reflected that some previous long-term goals are now being addressed by the committee's work
