Gooden updated the committee regarding its request of the City Manager's Office to send out its vetted recruitment letter as a press release through the City's Communications Coordinator. Planning- Greenspan attended the last meeting - nothing of substance to report.

Transportation - Tyler attended the last meeting - discussion included traffic issues on Oak and A street, teen drivers, and '20 is enough' push for traffic calming.

Parks - Smith attended the last meeting - discussion was mostly about pickleball.

Housing and Human Services - Mendel went to the last meeting - discussion centered on review of grant applications.

2200 Ashland St. Ad Hoc - Tyler attended the meeting on the previous day - discussion centered on what can be done with regards to developing housing options on the site.

DuQuenne shared about Mike Green's book AMERICA 250 and offered to invite BASE to speak to SERJAC. The committee discussed how to make comments while attending committee liaison assignments instead of only during respective public forums - Mendel will bring up this topic with committee chairs at the next regular CoCoConvo meeting.

**VI. New Business**

1. Discussion: Decision to not fly the Cesar Chavez flag this year and how to continue support for farm workers. (Gooden 5 min.)

Gooden reported on and referenced the news release. The committee will consider what can be done to recognize labor rights and farm workers next year.

We have chosen not to fly the Cesar Chavez flag this year, as we reassess how to commemorate farm workers and the broader movement for labor rights, dignity and fair working conditions. Since 2022, the City of Ashland has flown a Cesar Chavez flag the week of March 31. Recent allegations surrounding Cesar Chavez, however, has led multiple organizations, including the United Farm Workers, to pause celebrations and tributes. The legacy of farm worker advocacy extends far beyond any one individual, and Ashland remains committed to honoring and uplifting the contributions of farm workers and supporting the efforts that advance equity, safety and justice.

2. Belonging Survey - Results, analysis, etc. (Smith - 30 min.)

Smith presented and summarized his work with the draft analysis of the Belonging Survey results.

The committee discussed the breadth of the survey, themes emerging through analysis of responses, and the responsibility as an advisory committee to consolidate the report. It was clarified that SERJAC was not charged with solving any issues it uncovers, but rather to advise the Council 'on emerging issues and needs of the Ashland community as they relate to diversity, equity, inclusion, human rights and intergroup relations'.

Smith will send the draft summary to Gooden who will mark it as 'DRAFT' and distribute to the committee for further review and editing at the next meeting.

3. Equitable Housing Plan Working Group

This was discussed as on hold until HHSAC reaches out for support.

## A Welcoming Community

Ashland is committed to being a welcoming and safe community for all, regardless of immigration status. We want community members to feel informed, understand their rights, and know where to access trusted resources.

## Sanctuary and Inclusion

Ashland is committed to maintaining and defending its status as a sanctuary city—a safe and welcoming place for all residents. The City fully complies with Oregon’s Sanctuary Promise laws, which prohibit local law enforcement from using City resources to enforce federal immigration laws. If you have been a victim of or you have witnessed a crime, regardless of your immigration status, you are encouraged to contact the Ashland Police Department for help.

## Ashland’s Role in Immigration Enforcement

The Ashland Police Department does not ask about immigration status or assist with federal immigration enforcement unless legally required.

U.S. Immigration and Customs Enforcement (ICE) agents are not allowed access to non-public City spaces or documents without a federal judicial warrant. The Police Department does not act on ICE-issued administrative warrants.
